## Summary of findings

#### **Overall summary**

Chaseview Nursing Home provides personal care and nursing care to up to 60 older people. At the time of our inspection the service was supporting 45 people, some of whom were living with dementia.

We found the following examples of good practice.

- The registered manager had supported other local care homes by signposting them to government guidance and sharing examples of good practice during the pandemic.
- The management team had developed flexible yet safe visiting arrangements for people receiving end of life care to ensure people can spend time with their loved ones.
- The provider had set up an app where the management team can effectively monitor PPE, testing and staff well being daily.
- The provider had set up a direct line for relatives to contact them with queries or concerns around visiting the home and COVID-19.
- The management team supported staff wellbeing by purchasing regular treats for staff to lift their moods and thank them for their continued dedication.

## Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

This was a targeted inspection looking at the infection control and prevention measures the provider has in place. As part of CQC's response to the coronavirus pandemic we are conducting a thematic review of infection control and prevention measures in care homes.

This inspection took place on 17 August 2020 and was announced. The service was selected to take part in this thematic review which is seeking to identify examples of good practice in infection prevention and control.
