Summary of findings

Overall summary

Glebe House Care Home (Nursing) provides residential, nursing and respite care for older people who are physically frail. It is registered to accommodate up to 41 people. At the time of our inspection 29 people were living at the service.

We found the following examples of good practice.

Visitors to the service answered health screening questions, had their temperature taken, and contact details recorded for track and trace purposes. They were required to use hand sanitiser and wear a mask. Visits by relatives were booked in advance. The provider had created a safe visiting area with entrance doors from the garden and a large perspex windowed booth with chairs either side.

New admissions to the home from hospital had received a negative COVID-19 test and isolated for 14 days during which they were observed for any signs or symptoms developing. People were retested as soon as possible as part of the homes usual testing regime.

Staff wore a badge with their photograph and name which helped people to feel reassured and familiar with staff, despite them wearing face masks.

The registered manager had adapted the hairdressing salon to be used as a sanitising room for visiting health professionals. They used this room to put on personal protective equipment (PPE) and for belongings to avoid carrying them through the home.

Staff received update sessions on infection control by the manager in handover and supervision meetings. These took place in the lounge area for staff to socially distance.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the coronavirus pandemic we are conducting a thematic review of infection control and prevention measures in care homes.

The service was selected to take part in this thematic review which is seeking to identify examples of good practice in Infection prevention and control.
