Summary of findings

Overall summary

Prospect House Residential Home provides support and accommodation for up to 26 people, some of whom may be living with dementia. On the day of the visit 18 people lived at Prospect House.

Accommodation was located over two floors and there was an accessible lift available to use. All rooms at Prospect House were single occupancy.

We found the following examples of good practice.

Proactive management of the environment enabled staff and people living in the home to maintain social distancing, whilst allowing people to be cared for in a homely atmosphere.

The team had prioritised the safety and welfare of the people living at the home. We saw that assessments were in place to reduce risk. Managers and staff continued to review, implement and follow best practice guidance to keep people safe.

Regular, honest and open communication from the registered manager to relatives and friends and a heated garden 'pod' named the Chatterbox, provided assurance to relatives and allowed supported visits for people living in the home.

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the coronavirus pandemic we are looking at the preparedness of care homes in relation to infection prevention and control. This was a targeted inspection looking at the infection control and prevention measures the provider has in place.

This inspection took place on 30 March 2021 and was announced.
