## Summary of findings

### Overall summary

Roxton Nursing Home is registered to provide accommodation and personal care for up to a maximum of 45 people, some of who may be living with dementia. At the time of our inspection, there were 42 people living at the home.

We found the following examples of good practice.

People who had tested positive for Covid-19 were required to self-isolate in their rooms in line with current guidance. The provider zoned each floor to place everyone who had tested positive for COVID-19 on the same floors. Staff were allocated to work on specific floors to minimise the spread of infection.

Staff spoke to people individually to ensure they understood the risks of COVID-19 and when they would be required to socially distance and isolate.

People were supported to maintain contact with their families through telephone and video calls. A secure social media portal had been created to share pictures and information with families. A pod had been constructed to support family to visit people in the home when safe to do so.

People's social and emotional wellbeing was promoted by an activities co-ordinator who led activities in small groups while socially distanced. People who were unable to mobilise were supported to engage in activities individually in their rooms.

## Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of coronavirus, we are conducting reviews to ensure that the Infection Prevention and Control practice was safe and the service was compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place.

This inspection took place on 09 December 2020 and was announced.
