Summary of findings

Overall summary

Mapleton Court is a care home providing accommodation and personal care to older people, some of whom are living with dementia. The service can support up to 60 people in three adapted buildings.

We found the following examples of good practice.

The service had a dedicated unit to be used as a designated setting for people with a positive COVID-19 result. The designated unit has its own entrance and exit and access to the unit is only permitted to designated staff.

The service had effective systems in place to ensure all staff and visitors were doubly vaccinated unless they are exempt.

Staff had received training and understood their responsibilities in relation to infection prevention and control.

The premises were clean and well-maintained. Cleaning schedules were in place to ensure all areas of the home were regularly cleaned, including high touch areas such as door handles and light switches.

Hand sanitisers and PPE stations were situated throughout the building.

The service had effective processes in place, so laundry was managed safely.

The service had robust infection control auditing systems.

The management team were on call out of hours to support staff. They understood their responsibilities to monitor the quality and safety of the service to ensure people who used the service and staff were safe during the pandemic.

We were assured that this service met good infection prevention and control guidelines as a designated care setting.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

This was a targeted inspection looking at the infection control and prevention measures the provider has in place. As part of CQC's response to the coronavirus pandemic we are conducting a review of infection control and prevention measures in care homes.

The service had been identified for use by the Local Authority as a designated care setting in response to the Winter Plan for people discharged from hospital with a positive Covid-19 status. This inspection was to ensure that the service was compliant with infection control and prevention measures.

This inspection took place on 10 January 2022 and was announced.
