Summary of findings

Overall summary

Oakleigh is a residential care home providing accommodation for persons who require nursing or personal care. It is registered to provide care for up to 51 people and on the day of our inspection, 47 people were living at the service.

We found the following examples of good practice.

The premises were clean and well maintained. Additional cleaning schedules had been introduced since the beginning of the COVID-19 pandemic. High touch areas such as door handles and light switches were cleaned throughout the day and there were posters on display to remind staff of this. Hand sanitiser was readily available throughout the premises.

When a service user tested positive for COVID-19, staff placed a well-stocked supply of personal protective equipment (PPE) outside their room and a clinical waste bin to support the safe disposal of PPE worn by staff inside the room. Their clothes and bed linen were washed separately in red bags to prevent cross-contamination.

Visiting to the service was in line with government guidelines. At the time of inspection, the home was closed to all visitors other than essential care givers and where a person was receiving end of life care. People were supported by staff to remain in contact with their families in a COVID-safe way.

All staff had received recent training in infection prevention and control (IPC) and were seen to be following correct IPC practices at all times. The registered manager was accepting of all advice and guidance offered by external agencies including the local health protection team, CCG, Surrey County Council and CQC. The designated IPC lead shared all current policy government updates with staff and family members.

The registered manager and senior leadership team supported staff to provide people with good day to day care. The provider maintained a testing programme in line with current government guidelines for both staff and visitors to the service.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of COVID-19, we are conducting reviews to ensure that the Infection Prevention and Control (IPC) practice is safe and that services are compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 17 January 2022 and was announced. We gave the service 48 hours' notice of the inspection.

Our findings

Staffing

- The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures.

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was admitting people safely to the service.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.
- We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.
- We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.
- We were assured that the provider's infection prevention and control policy was up to date.
- We were assured the provider was facilitating visits for people living in the home in accordance with the current guidance.

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.

- The service was meeting the requirement to ensure non-exempt staff and visiting professionals were vaccinated against COVID-19.
